ORDINANCE NO. 1104-012020

AN ORDINANCE REASSIGNING COMMISSIONERS TO THE POSITION OF COMMISSIONER OF ACCOUNTS AND FINANCES, THE COMMISSIONER OF PUBLIC HEALTH AND SAFETY, THE COMMISSIONER OF STREETS AND PUBLIC IMPROVEMENTS, AND THE COMMISSIONER OF PUBLIC PROPERTY

WHEREAS, Section 4-5-3 of the Illinois Municipal Code (65 ILCS 5/4-5-3 (West 2018)) authorizes the members of the Oglesby City Council to designate, by a majority vote, one commissioner to be the Commissioner of the Department of Accounts and Finances, one Commissioner of the Department of Public Health and Safety, one Commissioner of the Department of Streets and Public Improvements, and one Commissioner of the Department of Public Property; and

WHEREAS, Section 4-5-3 of the Illinois Municipal Code (65 ILCS 5/4-5-3 (West 2018)) also provides that the Oglesby City Council can change this designation whenever it appears that public service would be benefited thereby; and

WHEREAS, the mayor and commissioners of the City of Oglesby have determined that public service would be benefited by rearranging the commissioners who have been appointed various positions.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The findings contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.
2. Commissioner Carrie Lijewski shall be appointed Commissioner of the Department of Public Health and Safety. Commissioner Thomas Argubright shall be

appointed Commissioner of the Department of Accounts and Finances. Commissioner James Cullinan shall be appointed Commissioner of the Department of Public Property. Commissioner Jason Curran shall be appointed Commissioner of the Department of Public Works.

3. This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
