AN ORDINANCE AUTHORIZING THE EXECUTION OF A MEMORANDUM OF
UNDERSTANDING BETWEEN THE CITY OF OGLESBY AND THE
OGLESBY FRATERNAL ORDER OF POLICE

WHEREAS, the City of Oglesby has in force a Labor Agreement with the Oglesby Fraternal Order of Police; and

WHEREAS, both the City of Oglesby and the Oglesby Fraternal Order of Police desire to enter into a Memorandum of Understanding which will modify portions of the Labor Agreement; and

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1 (West 2018)) authorizes the City of Oglesby to enter into union contracts with the Oglesby Fraternal Order of Police; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to enter into the Memorandum of Understanding.

NOW, THEREFORE, be it ordained by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby agrees to enter into the Memorandum of Understanding, attached to this ordinance and incorporated by reference as if set out in full herein.

3. After the passage of this ordinance, the Mayor of the City of Oglesby and the City Clerk of the City of Oglesby are authorized to sign the Memorandum of Understanding on behalf of the City of Oglesby.

4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
