ORDINANCE NO. 1156-031521

AN ORDINANCE AUTHORIZING DISPOSAL OF PERSONAL
PROPERTY OWNED BY THE CITY OF OGLESBY

WHEREAS, in the opinion of the corporate authorities of the City of Oglesby, it is no longer necessary, useful or in the best interests of the City of Oglesby to retain use of a 2004 Dodge Truck with plow; and

WHEREAS, the City of Oglesby has advertised for bids and desires to award the sale of the vehicle to the highest bidder; and

WHEREAS, Section 11-76-4 (65 ILCS 5/11-76-4) of the Illinois Municipal Code authorizes the sale of personal property no longer necessary or useful, or in the best interest of the municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are adopted and restated as if set out in full herein.
2. The City of Oglesby is hereby authorized to dispose of the 2004 Dodge Truck, which shall be sold to the highest bidder, Sonny Ball, for the sum of Two Thousand (\$2,000.00) Dollars.
3. The Mayor and City Clerk of the City of Oglesby are hereby authorized to sign all documents necessary to complete the transfer of ownership of the 2004 Dodge Truck with plow to the purchaser in exchange for payment in full of the purchase price.
4. This ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
